## **<u>CIRCULAR</u>**

In continuation of this office circular dated 31.05.2023 & 17.07.2023, i t is to inform all Pensioners that the Competent Authority has approved and empaneled the below mentioned health care organization / tie-up hospitals for providing Secondary, Super Speciality Treatment and Diagnostic Services to ESIC Pensioners at CHGS (NABH / Non-NABH) rates on Cashless basis under jurisdiction of Regional Office, Gujarat <u>for the period of 2 (Two) years w.e.f. 01.04.2024</u>.

Following procedures must be followed for availing Secondary, Super Speciality Treatment and Diagnostic Services in tie-up / empanelled hospitals:-

- a. All Pensioners will visit their respective Authorized Medical Attendant / Government Institutions of their respective areas on the first instance and obtain OPD / Secondary treatment there.
- b. If any medical treatment facility is not available with AMA / Government Hospital as mentioned in (a) above, the Pensioners concerned will obtain a reference letter from such AMA / ESIC hospital addressed to the CGHS approved hospital to the effect that the said medical treatment is not available there.
- c. The Concerned Pensioners will have to intimate in advance to this effect in writing to The Regional Director (CRI), ESI Corporation, Ahmedabad.
- d. The concerned Pensioners will produce the said reference letter in the above-cited tie-up hospitals. The Regional Office will confirm the reference to the said tie-up hospital by e-mail / post, on the basis of which treatment will be provided at the aforesaid hospital.
- e. The reference letter will only be provided to Pensioners for those services entered

with the respective empanelled / tie-up hospitals and available with them, since all services are not available and entered / engaged at CGHS rates with empanelled / tie-up hospitals.

- f. The beneficiary will be treated by empanelled centers as per referred diagnosis and the beneficiary / empanelled centers has to take permission for further treatment from ESIC wherever necessary.
- g. In the absence of referral letter from AMA, The Regional Director / SMO may act as an AMA in emergent situation only, if found necessary depending on case to case. But this clause will be used sparingly, only in exceptional cases.
- h. Indoor / In-Patient treatment can be availed in the emergent situation in any empanlled hospital on production of Medical / ID cards.
