2. Text Clause(s)

The bidders shall be bound to accept following adjustments at the contracted rates.

- The Purchaser / Competent Authority reserves the right to increase or decrease the bid quantity by up to 25% at the time of contract placement.
- The Purchaser / Competent Authority reserves the right to adjust manpower requirements as needed, including enhancing manpower strength by up to 35% of the total bid manpower, including relievers, on opening / commencement of the New OPD building in the MCH, SNR campus and its extended premises during Contract.

2. Generic

Products supplied shall be nontoxic and harmless to health. In the case of toxic materials, Material Safety Data Sheet may be furnished along with the material.

3. Service & Support

Escalation Matrix For Service Support : Bidder/OEM must provide Escalation Matrix of Telephone Numbers for Service Support.

4. Certificates

Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.

5. Payment

PAYMENT OF SALARIES AND WAGES: Service Provider is required to pay Salaries / wages of contracted staff deployed at buyer location first i.e. on their own and then claim payment from Buyer alongwith all statutory documents like, PF, ESIC etc. as well as the bank statement of payment done to staff.

Other instructions:

1. Duration of the service contract may be extended up to 12 months beyond the initial contract duration (subject to satisfactory performance and mutual consent).
2. **OPTIONAL SITE VISIT:**
 - i. The Bidder is advised to visit and examine the installation site and its surroundings and obtain for itself on its own responsibility all information that may be necessary for preparing the Bid. The costs of visiting the site shall be borne by the Bidder.
 - ii. The Bidder representative shall be allowed entry upon consignee premises for such visits, only upon the express conditions that the Bidder will release and indemnify the Buyer and Consignee against all liabilities arising out of such visit including death or injury, loss or damage to property, and any other loss, damage, costs, and expenses incurred as a result of such visit.
 - iii. The Bidder shall not be entitled to hold any claim against Buyer for noncompliance due to lack of any kind of pre-requisite information as it is the sole responsibility of the Bidder to obtain all the necessary information with regard to site, surrounding, working conditions, weather etc. on its own before submission of the bid.
3. Without prejudice to Buyers right to price adjustment by way of discount or any other right or remedy available to Buyer, Buyer may terminate the Contract or any part thereof by a written notice to the Seller, if:
 - i. The Seller fails to comply with any material term of the Contract.
 - ii. The Seller informs Buyer of its inability to deliver the Material(s) or any part thereof within the stipulated Delivery Period or such inability otherwise becomes apparent.
 - iii. The Seller fails to deliver the Material(s) or any part thereof within the stipulated Delivery Period and/or to replace/rectify any rejected or defective Material(s) promptly.
 - iv. The Seller becomes bankrupt or goes into liquidation.
 - v. The Seller makes a general assignment for the benefit of creditors.
 - vi. A receiver is appointed for any substantial property owned by the Seller.
 - vii. The Seller has misrepresented to Buyer, acting on which misrepresentation Buyer has placed the Purchase Order on the Seller.
4. Medical Fitness and Screening: It shall be the responsibility of the contractor to ensure that all employees deployed at the site, including housekeeping staff and supervisors, undergo a mandatory pr

e-employment/pre-induction medical check-up at the time of joining and at least an annual health check-up thereafter. These health evaluations must be carried out in accordance with the guidelines of ESIC Medical College & Hospital, Telangana Pollution Control Board (as per CFO conditions), HICC, and NABH.

6. As per government norms and extant rules, bidders must quote their service charges at a rate not less than 3.85% at Sl. No. 13 of Section A in the attached Excel sheet under the heading 'Excel Upload Required' in the GeM Bid document. Bidders who quote a service charge lower than 3.85% will not be considered in the financial bid.
 - Bidders are free to quote their own prices/rates for all items listed in Section C to Section G of the attached Excel sheet under 'Excel Upload Required' in the Financial Bid document.
7. Bidders must quote the prices for consumables, chemicals, personal protective equipment (PPE), and machinery of good quality and reputed brands that conform to relevant Indian Standards and bear the BIS ISI mark, wherever applicable. All such items must be purchased only from licensed vendors, and the contractor shall provide valid proof of BIS certification for each consumable, chemical, PPE, and machine supplied.
 - Products without BIS certification will not be accepted, and failure to comply with this requirement may lead to rejection of goods and/or termination of the contract. Every container, package, or box supplied must carry the manufacturer's descriptive label with complete product details including name, brand, batch number, date of manufacture, expiry date (if applicable), and usage instructions.
 - The products supplied must meet the satisfaction of ESIC Medical College & Hospital, Sanathnagar, in terms of both quality and quantity. Therefore, bidders must ensure they quote only for genuine, high-quality products of reputed brands. The responsibility of providing and maintaining the supply of such quality products lies solely with the bidder.
8. The values mentioned in the Price Bid Excel sheet are for reference only. Bidders must quote their own prices. Service charges at Sl. No. 13 of Section A must be quoted as a percentage, and shall not be less than 3.85%. Additionally, bidders must quote prices for all items listed under Sections C, D, E, F, and G. Failure to do so will result in rejection of the bid at any stage.
9. Bidders are **advised to quote their prices** on the GeM portal as follows:
 - The Other charges including Allowances over and above Minimum wage (% per Month) Inclusive of GST component shall not be less than 3.85% of the minimum wage (inclusive of GST).
 - The price for the "Monthly Volume of Garbage (in Tons)" should be quoted in such a manner that it bridges the gap between the total manpower-related charges (i.e., Minimum Wages per Month including ESI, PF, ELDI, PF Admin Charges, and relieving charges, inclusive of GST and service charges) and the final Total Offer Price. Bidders must ensure that the quoted amount under this head accurately balances the overall financial bid to match the total value specified in the Excel sheet, inclusive of all applicable taxes.

All GeM Sellers / Service Providers are mandated to ensure compliance with all the applicable laws / acts / rules including but not limited to all Labour Laws such as The Minimum Wages Act, 1948, The Payment of Wages Act, 1936, The Payment of Bonus Act, 1965, The Equal Remuneration Act, 1976, The Payment of Gratuity Act, 1972 etc. Any non-compliance will be treated as breach of contract and Buyer may take suitable actions as per GeM Contract.

This Bid is governed by the [General Terms and Conditions/सामान्य नियम और शर्तें](#), conditions stipulated in Bid and [Service Level Agreement](#) specific to this Service as provided in the Marketplace.
